REVISING THE IMPOSITION OF REGULATORY FEES FOR ALL RETAILERS/WHOLESSELERS, SERVICES, EATERLES, BUSINESS ENTERPRISES OPERATING WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR.

Be it Ordinance by the Sangguniang Bayan of the Municipality of Narvacan in session assembled.

Section 1. - Regulatory Fees. There is hereby provided that all Retailers/Wholesellers, Services, Eaterles, Business Enterprises operating within the territorial Jurisdiction of Narvacan, Ilocos Sur are hereby required to secure Regulatory Fees.
