AN ORDINANCE APPROPRIATING THE AMOUNT OF FIFTEEN THOUSAND PESOS (P15,000.00) FOR THE INSPECTION/VISITATION COMMITTEE, TRANSPORTATION, LUNCH MEALS, SNACKS AND OTHER EXPENSES IN CONNECTION WITH THE INTER-BARANGAYS AND INTER-SCHOOLS CONTEST IN CLEANLINESS, GREENING AND BEAUTIFICATION.

Be it enacted by the Sangguniang Bayan of Narvacan, Ilocos Sur in Session assembled;

Section 1 - The Municipal Council approved Municipal Ordinance No. 2 - 10 sponsoring an Inter-Barangay and Inter-Schools contest in cleanliness, and beautification to create civic consciousness and participatory involvement of the people in cleanliness, beautification and sanitary environmental atmosphere as a self reliant community.


Section 2 - Since the Municipal Beautification and Cleanliness of Narvacan, Ilocos Sur was authorized to conduct this Inter-Barangays and Inter-Schools Contest in Beautification, Cleanliness and Greening, and could not implement this contest without financial support.


Section 3 - The Municipal Government of Narvacan, Ilocos Sur, therefore shall appropriate Fifteen Thousand Pesos (P15,000.00) to finance the expenses to be incurred by the Committee on Inspection and Visitation - chaired by Miss Leonora V. Cauton - chairperson of the Municipal Beautification and Cleanliness Council.

Section 4 - The Fifteen Thousand Pesos (P15,000.00) shall be charged from any available funds from the Municipal Treasury.

Section 5 - This Ordinance shall take effect upon its approval.
