AN ORDINANCE PROHIBITING PEDDLING, HAWKING AND EXPOSING FOR SALE ANY ARTICLE OF COMMERCE IN PUBLIC PASSAGEWAYS, AISLES AND SIDEWALKS IN THE NARVACAN PUBLIC MARKET

BE IT ENACTED by the Sangguniang Bayan of Narvacan in session assembled:

Section 1. Title. This Ordinance shall be known as the "Municipal Anti-Peddling Ordinance" amending thereof Ordinance No. 2-13 Series of 1994.

Section 2. Definition of Terms.

- A. Peddler - any person who, either for himself/herself or for another person on commission basis, travels from place to place to sell or offer for sale any commercial item.
- B. Hawker - any person who, either for himself/herself or for another person on commission basis, cry out to sell commercial items along sidewalk and aisles in the public market.

Section 3. Prohibition. No peddlers, and hawkers or even stallholders are allowed to sell or offer for sale any commercial items along passageways, aisles, and sidewalks in the Narvacan Public Market.

Section 4. Penalty. Any person found violating any provision of this ordinance shall upon conviction be meted to pay a fine of:

- P 50.00 for first offense
- P 100.00 for second offense
- Cancellation of Mayor's Permit for third offense

Section 5. Final Provision

- A) Repealing Clause. All Municipal Ordinance, Municipal Executive Orders, Administrative Regulations, or parts thereof which are inconsistent with any of the provision of this Ordinance are hereby repealed or amended accordingly.
- B) Separability Clause. If, for any reason or person, any part or provision of this Ordinance shall be declared unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in force and effect.



C) Effectivity Clause. This Ordinance shall take effect upon approval.
