-AN ORDINANCE IMPOSING AND COLLECTING FEES AND CHARGES FOR SERVICES RENDERED OVER THE OPERATIONS OF NETWORK CELLSITE TOWERS WITHIN THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

BE IT ENACTED by the Sangguniang Bayan of Narvacan, Ilocos Sur, that:

SECTION 1 – The Local Government Code of 1991 (RA7160) empowers the Local Government Unit to impose and collect reasonable fees and charges for services rendered through an appropriate ordinance;

SECTION 2 – This type of facility did not exist during the enactment of the existing Revenue Ordinance of the Municipality of Narvacan, hence the said revenue ordinance does not mention or contain the corresponding service fee for the operations of network cell site towers;

SECTION 3 – There now exists the operation of network cell site towers in this municipality;

SECTION 4 – It is now therefore imperative on this municipality to impose and collect reasonable fees and charges specifically for services rendered over the operations of network cell site towers located within the territorial jurisdiction of the Municipality of Narvacan, Ilocos Sur in the amount of **TEN THOUSAND PESOS (P10,000.00) per annum** payable to the Municipal Treasurer within the first twenty (20) days of January or of each subsequent quarter as the case may be;


SECTION 5 – Failure to pay the fees shall result to surcharges of 25% of the amount of fee not paid in time;

SECTION 6 – All revenue ordinances inconsistent thereto are hereby repealed;

SECTION 7 – This ordinance shall take effect upon its approval by the Sangguniang Panlalawigan of the Province of Ilocos Sur.






