

ORDINANCE DECLARING DECEMBER 13 OF EVERY YEAR AS LOCAL SPECIAL NON-WORKING HOLIDAY IN THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

WHEREAS, traditionally, the people of Narvacan, Ilocos Sur commemorates its Foundation Day Anniversary every December 13;

WHEREAS, as a gesture of thanksgiving, the aforesaid date is focused mainly on sharing the blessings of our Divine Almighty;

WHEREAS, the sharing is done thru the various simple but meaningful activities that would enhance camaraderie, unity and cooperation from all sectors of our society;

WHEREAS, there are likewise other forms of mass or concerted actions such as parades, processions, demonstrations, and other activities of various schools, local and national offices as well as Non-Government Organizations (NGOs);

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of Narvacan in session assembled that;

SECTION 1. TITLE - This Ordinance shall be known as "**ORDINANCE DECLARING DECEMBER 13 OF EVERY YEAR AS LOCAL SPECIAL NON-WORKING HOLIDAY IN THE MUNICIPALITY OF NARVACAN, ILOCOS SUR**";

SECTION 2. COVERAGE - To declare **December 13** of every year as local special non-working holiday in the Municipality of Narvacan, Ilocos Sur;


SECTION 3. SEPARABILITY CLAUSE. If any provision or part thereof is held invalid or unconstitutional, the provision not otherwise affected shall remain valid and subsisting.

SECTION 4. Any law, presidential decree or issuance, executive order, rules or regulations contrary to, or inconsistent with the provisions of this Ordinance is hereby repealed, modified or amended accordingly.

SECTION 5. EFFECTIVITY CLAUSE. This ordinance shall take effect immediately upon approval and posted in three (3) conspicuous places within the municipality.




