

**APPROPRIATION ORDINANCE NO. 05-SS  
Series of 2019**

**AN ORDINANCE AUTHORIZING THE REALIGNMENT IN THE AMOUNT OF NINE MILLION PESOS (PHP 9,000,000.00) FROM THE UNEXPEND BALANCES OF FY 2019 20% DEVELOPMENT FUND**

Be it ordained in Special Session assembled:

**Section 1.** The Local Government Unit of Narvacan, Ilocos Sur for Fiscal Year 2019 is directing the realignment of the Unexpend Balances of FY 2019 20% Development Fund From January – December 2019 in the amount of Nine Million Pesos (P 9,000,000.00) for the Tourism & Socio-Cultural Programs/Projects/Activities of the Municipality of Narvacan, Ilocos Sur.

**Section 2. Sources of Funds.** The sources of funds for the Realignment in the total amount of Nine Million pesos (Php 9,000,000.00) shall be as follows:

**Section 3. Use of Funds.** The amount of Nine Million Pesos (Php 9,000,000.00) is hereby appropriated for the Realignment of the Unexpend Balances of FY 2019 20% Development Fund from January – December 2019 of the Local Government Unit of Narvacan, Ilocos Sur, to wit:
