ORDINANCE CREATING A SPECIAL ACCOUNT IN THE GENERAL FUND (SAGF) FOR THE BAYANIHAN GRANT TO CITIES AND MUNICIPALITIES (BGCM) AMOUNTING TO ELEVEN MILLION SEVEN HUNDRED AND TWENTY FOUR THOUSAND SIX HUNDRED AND THIRTY ONE PESOS (PHP 11,724,631) AND APPROPRIATING THE SAME FOR NARVACAN COVID-19 RESPONSE PROGRAMS, PROJECTS AND ACTIVITIES

WHEREAS, Section 4 of Republic Act No. 11469 or "The Bayanihan to Heal As One Act" granted the President the power to adopt various temporary emergency measures to respond to crisis brought about by the Coronavirus Disease 2019 (Covid-19) pandemic;

WHEREAS, President Rodrigo Roa Duterte approved Php 30.824 Billion "Bayanihan Grant to Cities and Municipalities" (BGCM) to be utilized solely for Covid-19- related programs;

WHEREAS, the Bayanihan Grant was sourced from the discontinued projects of some government agencies under Republic Act 11469 or FY 2020 General Appropriations Act;

WHEREAS, the grant is equivalent to one-month FY 2020 Internal Revenue Allotment share of the cities and municipalities to boost their capacity in immediately responding to the Covid-19 emergency;

NOW THEREFORE, be it ordained by the Sangguniang Bayan of Narvacan, Ilocos Sur that:

SECTION 1. By virtue of Section 4 of RA No. 11469, otherwise known as "The Bayanihan To Heal As One Act", granted the President the power to adopt various temporary emergency measures to respond to crisis brought about by the Coronavirus Disease 2019 (Covid 19) pandemic and consequently awarding the Bayanihan Grant to Cities and Municipalities.

SECTION 2. Sources of Funds. The amount of Eleven Million Seven Hundred and Twenty Four Thousand Six Hundred and Thirty One Pesos (Php 11,724,631.00) was awarded to the Municipality of Narvacan, Ilocos Sur as beneficiary of the "Bayanihan Grant to Cities and Municipalities".

SECTION 3. Use of Funds. The BGCN amount of Php 11,724,631.00 shall be solely appropriated for Narvacan Covid-19 response programs, projects and activities (PPAs) and expenses, such as:

SECTION 4. There is hereby created a Special Account in the General Fund (SAGF) for the "Bayanihan Grant to Cities and Municipalities" (BGCN) amounting to Eleven Million Seven Hundred Twenty Four Thousand Six Hundred Thirty One Pesos (Php 11,724,631.00) with the Municipal Mayor Luis "Chavit" C. Singson and the Acting Municipal Treasurer John David Barnachea as official signatories.

SECTION 5. Upon urgent certification of the Mayor and motion unanimously approved suspending the rule on the 3-day reading of Ordinances, this Ordinance shall be effective immediately upon approval.

SECTION 6. SEPARABILITY CLAUSE. If, for any reason or reasons, any part or provision of this Ordinance shall be held unconstitutional or invalid, other parts or provision hereof which are not affected thereby, shall continue to be in full force and effect.

SECTION 6. REPEALING CLAUSE. All ordinances, rules or regulations in conflict with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 8. EFFECTIVITY CLAUSE. This Ordinance shall be effective immediately upon approval.


