
WHEREAS, the Municipal Administration of Narvacan will shoulder the cost of round-trip air travel, per diems and other incidental expenses of each of the two program grantees;




WHEREAS, the Municipal Administration of Narvacan will shoulder the cost of round-trip air travel, per diems and other incidental expenses of each of the two program grantees;
