RESOLUTION REQUESTING HIS EXCELLENCY PRESIDENT JOSEPH EJERCITO ESTRADA FOR THE RELEASE OF THE RA 7171 MUNICIPAL SHARE DUE THIS MUNICIPALITY AMOUNTING TO TWENTY MILLION PESOS

WHEREAS, the RA 7171 municipal shares, as in the past, provide the funding mechanism to finance development projects in the municipality;

WHEREAS, the Municipal Administration has prioritized projects which will be funded from the RA 7171 Municipal Share as follows:


Improvement/Concreting of various Roads and flood control projects	P15M
Livelihood Programs	3M
Agricultural Farm Equipment/Systems	2M
Total	P20M


