**RESOLUTION ADOPTING THE BUSINESS ONE-STOP SHOP (BOSS) 2021 SCHEDULE AS RECOMMENDED BY THE BUSINESS PERMITS AND LICENSING OFFICE (BPLO) OF THIS MUNICIPALITY**

**WHEREAS**, submitted by the Business Permits and Licensing Office (BPLO) to the Sangguniang Bayan for its review, approval and adoption is the Business One-Stop Shop (BOSS) 2021 Schedule;

**WHEREAS**, the BOSS happens every first month of the year in the whole country to renew all the business permits, including the new applications for businesses;

**WHEREAS**, the BOSS 2021 Schedule submitted by the BPLO starts on January 4, 2021 and extends until February 26, 2021, except on Saturdays, Sundays and Holidays;

**WHEREAS**, the schedule, as indicated, is on a day-to-day basis for each and every barangay in the Municipality, as well as businesses and establishments in the town proper;

**WHEREAS**, the extension is given to accommodate the establishments who are not able to renew their permits at the given schedule and to avoid penalties, especially now that the cases of the Covid-19 pandemic are rapidly increasing;

**NOW THEREFORE**, on session assembled and on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to adopt the Business One-Stop Shop (BOSS) 2021 schedule as recommended by the Business Permits and Licensing Office (BPLO) of this Municipality;

**RESOLVED FURTHER**, that copies of this Resolution be furnished to the Office of the Municipal Mayor, to the Business Permits and Licensing Office, to the Municipal Treasurer's Office, to all the barangays, and to all offices concerned for their information and appropriate actions;

**RESOLVED FINALLY**, that copies of the BOSS 2021 Schedule be forwarded to all the barangays of this Municipality for their information and guidance.
